# 6. Early Childhood Education – Educacentre Partnership Program New Program Information and Completion Guide

For the past two years the Educacentre and Northern Lights College have been in partnership to offer the Early Childhood Education Certificate Program in French. All the courses are the same with the exception of French students having to take FRA 101 French Writing as opposed to ENGL 099 Foundation Writing. Both these courses are 45 hours, so the hours for both programs are the same. P. McClelland advised that the courses for both programs are also under review and will likely be revised for September 2010. D Owens questioned the minimum grade requirement of 60% to which J. Valgardson suggested that a policy statement regarding rationale for pass points in different programs be made on the Foundation for the Evaluation of Students document.

The Aboriginal Early Childhood Education Partnership Program is being offered through BCCampus in partnership with Northern Lights College, the College of New Caledonia, Northwest Community College and Yukon College. Courses will also provide an alternate program completion option for the Northern Lights College Early Childhood Education student. All agreed the credential should include the word

"Aboriginal" to differentiate it from the regular program. Percentages were removed from the typical weighting explanation section as this would limit instructors from apportioning this differently in the future. A. Hughes questioned all the information being presented in the "Other Pertinent Information Relevant to Transfer" section on the course outlines and P. McClelland explained that the Ministry requires that all competencies be shown on the course outlines for licensing purposes.

J. Valgardson relayed an expression of respect she received from the Northern Post Secondary Council, comprised of the University of Northern British Columbia, the College of New Caledonia, Northwest Community College and Yukon College, to Northern Lights College's Human Development and Education Care Department on their work in the Early Childhood Education area.

### 10. Editing/Consistency in Program Completion Guides

Many outlines refer to outdated information and use abbreviations instead of the expanded wording. Also there is a lot of repetition of information which is consistent for all the Programs but

is stated differently in each one. He proposes that the Marketing and Communications Department work with the Education Council to provide guidance in achieving consistency in our documents, including the production of "model" outlines. The general consensus of the members present was that it was an excellent idea.
