H. Mayer advised the Wind Turbine Maintenance Technician Program is a one year certificate program which goes from February of one year to January of the next, including two terms and one summer practicum. The 100% Residency requirement was questioned as there are a number of Workforce Training courses listed on the Program Information and Completion Guide which can be done at different institutions. H. Mayer agreed to lower the Residency requirement to 60%. H. Mayer explained that BZEE certification training can be offered by Northern Lights College as the instructor for the program has received necessary training; however, credentialing comes from the outside organization.

The numbering of the courses came into question as members felt it was very confusing and should be laid out more logically and sequentially. H. Mayer will supply a list of courses in the order of delivery and they will be renumbered to reflect the delivery sequence. It was also suggested and agreed upon that the Applied Business Technology courses be listed as co-requisites as opposed to pre-requisites.

## 5. Early Childhood Education and Care Diploma New Program Information and Completion Guide

P. McClelland explained that current Early Childhood Education Diploma program has been offered by Northern Lights College; it is being revised to reflect progressive trends in program area. Colleges are moving away from one year certificate programs with a two year diploma program becoming the standard. The Human Development and Education Care Department is therefore shifting the program from a vocational to an academic model to allow for more transferability to other institutions. This change will also respond to the need for fully trained Early Childhood Education professionals in all inclusive child program areas from birth to six years of age. A few grammatical changes were suggested to the Calendar description and P. McClelland made two minor corrections to the Required Courses section.

# 8. University Arts and Sciences, New Course HIST 209 History of the First Nations of Canada

Northern Lights College is working on presenting the "Online Associate of Arts in First Nations Studies" in collaboration with five other Colleges. To date none of the other collaborating institutions are offering this type of course on line. As well as filling a need in the province for this course it would also be available to different programs within our institution. Some concern was expressed over the learning outcomes vocabulary, and E. St. Jean agreed to provide more concise terminology.

# 9. Bridging Programs New Program Information and Completion Guide Criminology Bridging Certificate

The Criminology Bridging Certificate has been brought back to Council with the suggested amendments in place. The length of the program has been revamped to fit within the one year certificate criteria and also the duplication of the two English courses has been addressed. Completion of the Criminology Bridging Certificate simultaneously permits students who have not graduated from high school to obtain the BC Adult Graduation Diploma (the Adult Dogwood). S. Roe agreed to remove one sentence out of the Career Prospects section with negative connotations.

# 10. University Arts and Sciences New Program Information and Completion Guide Diploma in Criminology

The science requirements for the Associate of Arts Degree presents a barrier for Northern Lights College students who want to pursue a two-year credential in Criminology. The Diploma in Criminology would not replace the Associate of Arts Degree with a Specialization in Criminology, but provide an option for students. Transferability to other institutions should remain strong. The Required Courses section should present a simple list rather than a planning grid, unless required by program singularities.

### 13. Land Agent Program

Revised Program Information and Completion Guide Land Reclamation Program Revised Program Information and Completion Guide New Courses:

Due to ongoing difficulties finding instructors with Masters Degrees who can teach academic course FNST 102 Treaties and Aboriginal Rights, it was decided to create an equivalent non-academic course LAND 111. The reverse is true for LAND 276 Introduction to GIS--because it is a highly transferable course it was decided to create an academic equivalent that could be articulated and transferable. This would also make the course available to students in other programs that require an academic geography course. Some grammatical errors were detected and corrected.

### 14. Academic Monitoring

A. Hughes advised the Council that at present there are no formal processes in place to monitor a student's academic performance and therefore we have students who are having difficulties, slipping through the cracks, enrolling in courses numerous times and not having success. Northern Lights College, as an educational institute needs to identify these students to help them break out of this cycle. C. Herbert suggested that some clarification be made regarding the last line of the document which states: "A course may not be repeated more than twice within five years." and change it to read: "A course may be taken once and repeated twice, to a maximum of three times within five years." A. Hughes said she would take this into consideration and make a change to provide more clarity to the statement.
