#### 4. Applied Business Technology Online Program, New Outlines, ABTO XXX Medical Transcription, ABTO XXX Medical Terminology I, ABTO XXX Medical Administrative Procedures, ABTO XXX Medical Terminology II and Related Anatomy and Physiology

Course content and learning outcomes are identical to BCcampus outlines. Four more courses will be coming forward for approval for a total of eight courses constituting a Medical Certificate. There are three Applied Business Technology certificates: Medical, Legal and Administrative. If Council does not approve the outlines students can register with another institution, but will likely remain with that institution for additional courses. Northern Lights College teaches and registers students, while some institutions only teach or register.

Medical Transcription – no course content was provided in the BCcampus outline; only the calendar description appears on the BCcampus website. NLC requires both course content and learning outcomes for approval. The outline is to go back to the Dean for further consideration.

Council would like to have a copy of any Academic program documentation concerning policy for weighting of grades.

- Geomatics Engineering Technology Year 1, New Outlines, COMM 100 Technical Communication 1 for Geomatics, COMM 110 Technical Communication 2 for Geomatics, MATH 100 Technical Mathematics for Geomatics, SURV 100 Surveying Computations 1, SURV 101 Surveying CAD 1, SURV 102 Field Surveying 1, SURV 103 Computer Applications 1, SURV 110 Surveying Computations 2, SURV 111 Surveying CAD 2, SURV 112 Field Surveying 2, SURV 113 Computer Applications 2, SURV 114 Earth Sciences, SURV 115 Photogrammetry

The outlines presented come from a partner institution, with whom we have a block transfer agreement. There is some information missing on the outlines that will be backfilled as new instructors teach courses for first time. NLC will teach the approved outlines for one year and come back to Council with updates.

COMM 100 – minor revision to the calendar description. Grading System – change to percentage, but indicate a passing grade of percentage and letter grade. All outlines to reflect this change.

COMM 110 – revision to calendar description. Learning Outcomes – use the word "employ" for the last two outcomes. Grading should be percentage

THAT the Education Council recommends approval of the new course outlines, COMM 100 Technical Communication 1 for Geomatics, COMM 110 Technical Communication 2 for Geomatics, as amended, for the Geomatics Engineering Technology program.

#### CARRIED

MATH 100 – prerequisite – it should state, Math 12 (Principles of Math or Math 050) or equivalent. The credits are indicated at 7; NLC's 105 hours courses only have 4 credits. E. Sehn stated that the credits are irrelevant as this is not an academic course. The textbook publisher information could not be confirmed at this time.

SURV 100 – change grading to percentage. Textbook information on chapters covered not available at this time.

G. Rounds left the meeting at 3pm

SURV 101 – learning outcomes - add statement, "upon successful completion the student will be able to." There is no attendance policy in our calendar so remove the reference from the additional comments section. Academic courses use letter grades and Career Technical programs use percentage, except Land programs, which use letter grades. E. Sehn indicated that the academic courses that are part of the Geomatics program will use percentage for grading. If academic students register for only the Geomatics academic courses then they will be graded using letter grades.

THAT the Education Council recommends approval of the new course outlines, MATH 100 Technical Mathematics for Geomatics, SURV 100 Surveying Computations 1, SURV 101 Surveying CAD 1, as amended, for the Geomatics Engineering Technology program.

SURV 102 – calendar description minor revision. Content – remove the first sentence and the lab references. Learning outcomes – change "understand" to "define." Typical weighting – no percentage indicated for participation, but attendance is taken for field labs, as outlined in the additional comments section. Eric commented that if the program completion guide indicates attendance then the program can adopt the policy from the Trades Department.

SURV 103 – course content - minor revision.

SURV 110 – number of assignments not indicated as there is no information at this time from the partnering institution.

SURV 112 – grading – use percentage.

SURV 113 – learning outcome #6 – missing a verb (E. Sehn to confirm).

SURV 115 – total hours 20 hours a week. Calendar description – minor revisions. Number of assignments – remove "one quiz" and add to the additional course comment section. Clarification is needed next time for labs and assignments.

#### 9. Health Care Assistant, Revised Program Information and Completion Guide

A name change from Home Support/Resident Care Attendant to Health Care Assistant effective for the July 2009 intake.

The Solicitor General's Office Bill 16 states that anyone dealing with young children, or in a care home or infirmary setting must have a Criminal Record Search (CRS) completed. A second CRS must be completed with the RCMP. The College will only be notified if there is a problem; we will not hold the Criminal Records Searches. The College becomes the authority on whether the student is accepted or not based on any flag on the CRS.
