## 1. Adoption of Agenda - 1:03

#### 2. Adoption of Minutes, June 24, 2009

#### 3. Action List Review

When questioned as to why the Criminology Bridging Certificate submission was not resubmitted and why the FNST 100 Aboriginal Peoples of Canada submission was withdrawn, E. Sehn explained that the Criminology Bridging Certificate would be revisited at a fundamental level and would possibly be resubmitted at a later date. The academic outline, FNST 100 Aboriginal Peoples of Canada, was withdrawn as the department did not wish to pursue any changes to this course and decided to keep it in the original format. P. McClelland volunteered to join the Student Evaluation Committee to replace P. Adams if her participation would be helpful.

#### **Decision Items**

4. Workforce Training Program, New Course - Resubmission **WFTR 805 Heavy Equipment Operator Assessment** 

In the original submission of this course outline, many Council members felt that prospective students reading the Calendar description might be misled into thinking they would be certified on all four pieces of equipment (Graders, Loaders, Excavators, and Dozers) at the conclusion of their assessment. In this resubmission of WFTR 805 Heavy Equipment Operator Assessment, H. Mayer reworded the calendar description to specify that each participant must demonstrate knowledge on the piece of equipment they wish to be certified for. In order to clarify that participants require a minimum of 5000 hours of accumulated experience on a range of equipment, G. Lainsbury suggested the word 'cumulative' be inserted into the first sentence of the calendar description to succinctly describe this requirement. All agreed.

Together, D. Merry, A. Hughes and J. Lekstrom agreed to rewrite the calendar description to provide a clearer depiction of the program.

Lainsbury suggested some grammatical changes to the calendar descriptions for WPES 002 Literacy, WPES 003 Numeracy and WPES 004 Workplace Communications which all agreed would clarify the statements.
