Decision Item(s)

- 5. Revised Program Guide for Welder Apprenticeship, Welder Foundation and Welder Endorsement: Multi-Process Alloy Welding (MPAW) and New Course Outlines WELA 100, WELA 200, WELA 210, WELA 300, WELF 101 and WELA 310.
 - R. Cork explained that the revisions bring the Welding programs in line with the CDA harmonization initiative. He added that there were also slight update to names, mnemonics and numbering for the programs and courses.
 - B. Kulmatycki asked about student transition within the programs. R. cork explained that WELA 210 is the gap training course created by the ITA and that ITA is funding the course. He added that he was unsure about how long the ITA will fund this transition step.
 - W. Stokes asked about the effective dates of April 2017. R. Cork answered that courses would occur between April and Sept.
 - W. Stokes asked about the admission requirements for Welder Foundation regarding the listing of both percentage and grade. As both high schools and CCP report the letter grade only a decision by Education Council to remove the percentage from all Welding Program admission requirements was made. W. Stokes asked about the wording of the last paragraph of the Admission Requirements for Welder Foundation. R. Cork explained that it existed in the previous program guide language and M. Bedell stated that it had been used in the past with former students.
 - W. Stokes asked about the former course code listed for WELA 310. R. Cork explained that WLAT 400 should be listed as the former course code and added that the new course code of WELA 310 is correct as the course was not a fourth year course

6. Revised Program Guide for Carpentry Apprenticeship and New Course Outline CARA 100.

- R. Cork explained that the revisions are to bring the Carpentry program in line with the CDA harmonization initiative. He added that there were also slight updates to name, mnemonic and numbering for the course. He further explained that we will have only level one at this time.
- R. Cork noted a minor change that needed to be made to the CARA 100 course outline regarding breakdown hours. The Lecture hours were updated to 119.7 and the Shop/Kitchen hours were updated to 90.3.
- W. Stokes asked about the effective date of April 2017. R. Cork explained that it would be offered prior to September 2017.
- W. Stokes added that the program guide will need to come to council with each of the additional levels as they are released by the ITA.

- B. Kulmatycki asked about naming a chair of the subcommittee. J. Christunesam stepped forward to be the chair.
- B. Kulmatycki asked if there was a time line for the subcommittee. F. Rashid explained that this should be a 1-2 month time line.

Subcommittee Standing Reports

- **8. Education Policy Subcommittee** A. Holloway reported that the Feb 17th meeting was cancelled due to scheduling conflicts. The next meeting is scheduled for March 17th.
- **9. Curriculum Subcommittee** A. Holloway reported that the subcommittee met on Feb 2nd to discuss the documents for the February meeting. The next meeting is scheduled for March 2nd.
- **10. Admissions and Standards Subcommittee** M. Bedell will bring draft of Terms of Reference to next meeting.

Information/Discussion

- **11. Policy on 'Registration Priority' First Draft** W. Stokes explained that the policy would be for when a student is registering and not an 'Admissions' policy. He further explained that historically NLC managed registration by cohorts but there were administrative and staffing challenges. He added that online registration will now be happening and a process needed to be built. He further added that he went to the TAG group for discussions regarding the new policy. He explained that there needed to be balance regarding students that are at the end of their schooling.
- T. Donnelly asked about continuing education students. W. Stokes explained that those students will still be the same process as before (first come/paid, first served).
- S. Miller asked if there was a date window as well. W. Stokes answered that yes, there will be a commencement date. He then explained the concept of re-admitted students.

- S. Roe asked about the order of registration, wanting to maximize course accessibility and recognizing domestic students that would have lower credit numbers. He added that he wondered if they could instead look at distance to Program Completion instead. W. Stokes explained that the challenge becomes making sure that registration knows what the student actually plans to complete/graduate from. He added that PLAR and transfer credit would come into the discussion as well.
- W. Stokes reported that TAG did worry that 0-30 was too big of a group and could possibly miss the certificate students. S. Roe agreed with W. Stokes that 0-15 sounded like a better range.
- S. Roe asked to have a cross-department test group to work with the Intersession and give it a peer review for the process.
- S. Roe inquired about the capacity for on-line registration. W. Stokes explained that they will in fact not know the capacity until it is tested. He added that other institutions (including CNC) are using the same framework and that NLC should be able to handle the capacity.
- **12. CE Course Outlines** T. Donnelly explained the new continuing education courses.
- T. Donnelly and W. Stokes will be looking into revising the numbering system for CE courses to ensure they have unique numbering.
- C. Page asked if we are looking into making some of these courses available online at some point. T. Donnelly answered that she is hoping to have the classes videotaped and having that available to individuals.
- **13. BIOL 101 and BIOL 102 Submission (Jan 2017) Discussion** S. Roe explained that there was an Education Council decision to have more information and that there were administrative questions that needed to be answered.
