### 7 Revised Practical Nursing

L. Sprinkle explained the submission:

At the direction of the British Columbia College of Nursing Professionals (BCCNP), all BC post-secondary institutions that offer Practical Nursing Programs must revise course outlines in order to comply with the updated *Practical Nursing Program Provincial Curriculum Guide*, 2<sup>nd</sup> Edition, 2017.

The *Curriculum Guide* revisions required by BCCNP focus on detailed course content and learning outcomes, and reflect an expanding scope of practice for Licensed Practical Nurses. Program hours remain the same.

Internally, the NLC program team has taken this opportunity to acknowledge post-admission requirements (listed in the current Program Completion Guide) as non-course prerequisites for all of the consolidated practice experience courses and for the final preceptorship.
