- P. Nunoda advised K. Vandewalle was not able to attend the meeting and he would be making the presentation along with Brian Larsen of Keyera Energy whom he had invited to the meeting. B. Larsen joined the meeting from his Calgary office via teleconference. He explained his long term experience with Lakeland College in Alberta, both as its President and his affiliation through Keyera Energy and the work that has been done over the past ten years to develop the programs we are reviewing today using their Competency Management and Development System (CMDS). The Competency Management and Development System is a comprehensive competency based approach to evaluating workers (students) in their petroleum industry related jobs. To date, Lakeland College has awarded approximately 2000 certificates, involving over 60 different oil and gas companies in Alberta.
- P. Nunoda inquired as to the 'quality assurance' question and how can Northern Lights College ensure the validity of these certifications as they come through the different industries. B. Larsen replied there are a number of different checks and balances. There are internal mechanisms in place when an application comes through the employer to Keyera Energy. Subject matter experts are trained as Validaters at Red Deer College in Alberta and have a strict protocol they have to follow to ensure the student meets their profile requirements successfully. This process can take approximately one year to complete. Both the Validater and a CMDS manager will sign off that these requirements have been successfully met before the certificate can be issued.
- L. Rancourt pointed out this is a Workforce training initiative, once this is approved, the programs will not be posted to the College website to be advertised as regular programs. It may be mentioned on the Workforce training webpage that this is an option offered through specific employers. B. Larsen confirmed, the programs are advertised on the keyeracmds.com website to participating employers only.

Concern was expressed as to how this might impact our own Oil and Gas Field program and assurance was given that these new programs would not detract from our regular programs since the target students are totally different. Our regular programs are for those students interested in entering the Oil and Gas Industry and the Keyera programs are for those already employed in the industry.

P. Nunoda advised he has looked at the Keyera programs and is impressed with Keyera's thoroughness.

6. Clean Energy

New Course Outlines:

- a) CLEN 057 Fundamentals in Math and Physics
- b) CLEN 101 Building Site and Design

S. Roe advised CLEN 057 Fundamentals in Math and Physics and CLEN 101 Building Site and Design are the last two course outlines being looked at for approval for the 2012-2013 intake of the Clean Energy program. He requested an additional line to the learning outcomes of CLEN 057. Some questions were raised as to the 'pass' percentages of 70% and S. Roe clarified this is the accepted pass percentage for trades programs. In the new program guide, applicable to the 2013-2014 intake which is being looked at next on the agenda, the passing grade has been changed since it will be a more career/technical based program. He added these course outlines will in all likelihood also have to be updated once the first intake (2012-2013) is completed.

7. Clean Energy

Revised Program Information and Completion Guide for 2013 start date

S. Roe clarified this program guide is not a revision to the program which is being offered for the 2012-2013 year under an Employment Skills Access (ESA) contract but is an update, changing the program to more of a career technical model and being offered starting in the 2013-2014 school year to the general public. Admission requirements have increased but still allows for flexibility in math. Considerable discussion followed regarding the Residency Requirement of 100%. Many felt this did not allow for any Prior Learning Assessment and may eliminate potential students. P. McClelland suggested including the term 'or approval of the Dean' in the Residency Requirement which would allow some leeway to students seeking admittance on the basis of prior learning assessment. S. Roe agreed. L. Rancourt felt this may require some future discussion and asked that it be placed on the Action List.

ACTION: Discuss Residency Requirement and decide on a base minimum percentage.

J. Bowman raised the issue of only allowing students 5% absenteeism in the program and how this may impact the 8-10% of our student body with disabilities. He acknowledged the caveat that states the College will attempt to be flexible but felt it needs to be more explicitly stated in a more tolerant manner. D. Batterham suggested discussing this on the Action List as well. L. Rancourt agreed and cautioned when there is legality involved we have to make sure we are using the proper language in the right way in the right context.

ACTION: Develop 'absenteeism percentage language' in relation to disabled students making it applicable to all programs.

- P. McClelland advised the Aboriginal Early Care and Learning program has been in development for the past two years. The program is being offered on-line through BC Campus as a collaborative program involving, Northern Lights College, Nicola Valley Institute, Yukon College and the College of New Caledonia. A certificate program information and completion guide and three courses outlines were approved in August of 2009 and has now been expanded to include a diploma program as well. P. Nunoda felt the Aboriginal program should have had common streaming with our regular program and then branched out to an Aboriginal credential. P McClelland agreed however it was more important to parallel other institutions in the collaborative who will all be contributing to instructing the courses.
