4. SOST 040 Course Outline

K. Lewis explained that the submission consisted of revisions to the SOST 040 Course Outline:

She further explained that CCP courses were required to be reviewed by the College and any revisions brough to Education Council about every 7 years, to be provincially articulated.

W. Stokes noted that the Course Description did not include a statement regarding the equivalency to a course like (as an example) Socials Studies 11. K. Lewis explained that it was a philosophical question/debate that the group discussed but ultimately, they decided not to include it. She added that it was not provincially mandated either way.

Manning answered that "Building Maintenance" is a credentialed and recognized trade.
